

**WARNING AND NOTICE: SPECIAL TOWN MEETING**  
**Monday, June 22, 2009**

The legal voters of the Town of Moretown are hereby warned and notified to meet at the Town Clerk's Office in Moretown Village at 7:00 a.m. on June 22, 2009 to act upon the following matters:

1. Shall the voters of the Town of Moretown approve the expenditure of a sum of money not to exceed \$8,200.00 to pay invoices relating to the quarry litigation, in lieu of paying the expenditure by taking from other line items in the existing town budget that was approved by the voters on March 3, 2009? Voting to be by Australian ballot. Polls will be open from 7:00 a.m. to 7:00 p.m.
2. Shall the voters of the Town of Moretown approve the expenditure of a sum of money not to exceed \$15,000.00 from the Capital Reserve Fund to pay for an audit of the 2008 financial records, in lieu of paying the expenditure by taking from other line items in the existing town budget that was approved by the voters on March 3, 2009? Voting to be by Australian ballot. Polls will be open from 7:00 a.m. to 7:00 p.m.
3. Shall the voters of the Town of Moretown approve the expenditure of a sum of money not to exceed \$ 25,000.00 from the Capital Reserve Fund to pay invoices related to the new town garage project, in lieu of paying the expenditure by taking from other line items in the existing town budget that was approved by the voters on March 3, 2009? Voting to be by Australian ballot. Polls will be open from 7:00 a.m. to 7:00 p.m.

The Town Clerk's Office will accept applications for persons' names to be placed on the checklist until 5:00 p.m. on the Wednesday preceding the day of the election, which is June 17, 2009. For the purposes of voter registration, a mail application or an application submitted to the department of motor vehicles in connection with a motor vehicle driver's license or an application accepted by a voter registration agency shall be considered to have met the filing deadline established by this subsection if the application is postmarked, submitted or accepted by 5:00 p.m. of the Wednesday preceding the day of the election.

Absentee ballots will be available at the Town Clerk's office 20 days prior to the election, which is June 2, 2009.

**Notice of public meeting** - There will be a public information meeting held at the Moretown Town Hall in Moretown Village on Monday, June 18, 2009 at 7 p.m. in the evening. Since all articles involving over \$5,000.00 are to be voted on by Australian ballot, it is important for voters to attend this public informational meeting.
